# ITEM NO. 1

#### **DIRECTOR'S REPORT AND COMMISSION BUSINESS**

- Ken Bernstein, Principal City Planner reported the following:
  - Travel to San Antonio, Texas, along with Aaron Gross, Mayor Garcetti's Chief Resilience Officer, to participate in a two-day "peer exchange" on "Climate Heritage", bringing together the historic preservation officers and chief resilience or sustainability officers from the cities of New York, Boston, San Antonio and Los Angeles. It was a very productive opportunity to discuss how big cities can adapt to a changing climate and address the growing threats to our cultural heritage from sea level rise in coastal areas, increased wildfires, and other climate challenges. We also focused on the role our historic buildings can play in climate mitigation, reducing carbon emissions and there were excellent lessons learned from the other cities including a Resilient Building Design Guide in Boston, a proposed building materials salvage ordinance in San Antonio, and New York City's "carbon challenge" program getting commitments from property owners to reduce greenhouse gas emissions. We'll be following up with the Mayor's Office on initiatives here in Los Angeles and I'll keep the Commission updated on our efforts.
  - For City Council actions, the Council has returned from its July recess and this week approved HCM nominations for two properties, the Comedy Union on Pico and the Green Dog and Cat Hospital on Slauson. In addition, the Council yesterday approved initiation of the nomination for Bothwell Ranch, located in Tarzana, near the border of Woodland Hills, a 12-acre property that appears to be the last remaining commercial orchard in the San Fernando Valley.
