Photographs do not count toward the page limitation. **Day of Hearing Submissions** within 48 hours of the meeting, up to and including the day of the meeting are limited to 2 pages plus accompanying photographs. Day of Hearing Submissions are to be submitted electronically to cpc@lacity.org and 15 hard copies must be submitted at the in-person meeting. Submissions that do not comply with these rules will be stamped "**File Copy. Non-Complying Submission.**" Non-complying submissions will be placed into the official case file, but they will not be delivered to or considered by the Commission, and will not be included in the official administrative record for the item at issue.

PUBLIC HEARING REQUIRED

PROJECT SITE: 1002 North Alfred Street
(1000 – 1014 North Alfred Street; 8445 – 8447 West Romaine Street)

PROPOSED PROJECT:

Construction, use, and maintenance of a new five-story, 56-foot tall apartment building containing 67 units. The Project is setting aside six units for Very Low Income Households and one unit for Low Income Households. The Project proposes to provide 43 automobile parking spaces within a subterranean parking level and will also provide a minimum of 46 long-term bicycle parking spaces and five short-term bicycle parking spaces. The proposed building will encompass approximately 52,041 square feet in total buildable area resulting in a Floor Area Ratio (FAR) of 3.72:1.

APPEAL:

A partial appeal of the January 26, 2023, Director of Planning's determination which:

1. Determined, based on the whole of the administrative record, that the Project is statutorily exempt from the California Environmental Quality Act (CEQA) as a ministerial project, pursuant to Government Code Section 65915(1)(5) and (j)(1) and California Public Resources Code Section 21080(b)(1);
2. Approved with Conditions, pursuant to Section 12.22 A.25 of the Los Angeles Municipal Code (LAMC), a ministerial review of a Density Bonus Compliance Review with a 35 percent Density Bonus (with 11 percent of the base number of units set aside for Very Low Income Households), for a project totaling 67 dwelling units, including six units for Very Low Income, for sale for a period of 55 years, along with the following two On-Menu Incentives:
 - a. An On-Menu Incentive for an 11-foot increase in building height to permit a maximum building height of 56 feet in lieu of the 45 feet otherwise permitted; and
 - b. An On-Menu Incentive for a Floor Area Ratio (FAR) increase to permit a maximum FAR of 3.72:1 in lieu of the 3:1 otherwise permitted; and
3. Adopted the Conditions of Approval and Findings.

PROPOSED AMENDMENT:

The proposed amendment to the Site Plan Review Ordinance would amend Section 16.05 of the Los Angeles Municipal Code (LAMC) in order to streamline the permitting of new affordable housing units. The proposed amendment to the Site Plan Review Ordinance would exempt deed restricted affordable units from the 50-unit Site Plan Review threshold calculations.

REQUESTED ACTIONS:

1. Recommend that the City Council find, the Project was assessed in the Housing Element Environmental Impact Report (“EIR”) No. ENV-2020-6762-EIR, State Clearinghouse (SCH) No. 2021010130 certified on November 29, 2021 and the Addendum (ENV-2020-6762-EIR-ADD1) approved June 14, 2022;
2. Approve and Recommend that the City Council adopt the proposed Ordinance;
3. Adopt the staff report as the Commission’s report on the subject;
4. Recommend that the City Council instruct that the proposed Ordinance be incorporated into the New Zoning Code, subject to changes to conform to the format and style of the New Zoning Code; and
5. Adopt the Findings.

PUBLIC HEARING – Completed February 8, 2023

PROJECT SITE: Citywide

PROPOSED AMENDMENT:

The proposed Al Fresco Ordinance would amend Sections 12.03, 12.10.5, 12.11.5, 12.12.2, 12.13, 12.13.5, 12.14, 12.21, 12.21.1, 12.22, 12.24, and 16.02.1 of the Los Angeles Municipal Code (LAMC) to clarify and streamline Zoning Code regulations regarding outdoor dining on private property. As proposed, outdoor dining that complies with the applicable standards would be permitted as a by-right use in any zones where restaurants are currently permitted. Any outdoor alcohol service would continue to require compliance with all applicable zoning regulations as stated in an existing or new discretionary approval or in compliance with the proposed ministerial approval.

REQUESTED ACTIONS:

1. Recommend that the City Council determine, based on the whole of the administrative record, that the Project is exempt from CEQA pursuant to California Public Resources Code Section 21080.25 and CEQA Guidelines, Section 15303 and Section 15311, and there is no substantial evidence demonstrating that an exception to a Categorical Exemption pursuant to CEQA Guidelines, Section 15300.2 applies;
2. Approve and Recommend that the City Council adopt the proposed Ordinance;
3. Recommend that the City Council instruct that the proposed Ordinance be incorporated into the New Zoning Code (future Chapter 1A of the Los Angeles Municipal Code), subject to changes to conform to the format and style of the New Zoning Code;
4. Adopt the Staff Recommendation Report as the Commission's Report on the subject; and
5. Adopt the Findings.

TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
