Hi Eduardo,

Here is a rough estimate on the costs for Hollywood route:

One 35 ft zero emission bus procurement cost, 3 years Maintenance of the bus, 3 years driver salary (\$20/hr, 12 hrs/day, 7days/week) is estimated at \$4,228,196 if you want to add fuel (\$93.77 day/5 hr charge @ 155 miles/Charge @ 3 years) estimate at \$1,330,874.

Vehicle \$865,386 Maintenance \$100,000 Driver \$262,800 Fuel \$102,678
