Ord. 184248 Savings = [24 AFY (indoor) + 3 AFY (cooling)] / 578 AFY = **4.7%**

4.7% out of 20.0% Ordinance Savings is due to Ordinance 184248 (effective 6/6/16). It does not necessarily mean prior to Ordinance 184248 was adopted, developers would have voluntarily committed to the same level of conservation that is now required. For example, Ord. 184248 lowered the maximum flow rate of showerhead from 2.0 gpm to 1.8 gpm. Now developers are required to install 1.8 gpm or less for showerhead, but prior to the adoption of Ord. 184248, not all developers voluntarily committed to use 1.8 gpm showerheads.
