7,200 tons of cooling was converted to 5,760 tons of chiller capacity by 7200\*(12,000 Btu per hour/15,000 Btu per hour).

To verify this number, I used the square footage breakdown of the proposed project's scope to estimate the total estimated chiller capacity, which was close to 5,760 tons.

What assumptions did you make for estimating water usage by the cooling towers? The reason I'm asking is that we are analyzing alternatives right now and want to apply the same assumptions for calculating water usage for each of the alternatives. That way, we can have an apples-to-apples comparison when looking at the water usage of each alternative against that of the Project. FYI, none of the alternatives are larger than the Project, but we'd like to be able to quantify instead of just stating that each of the alternatives would have less water demand than the Project.





I am preparing for our internal meeting prior to the board meeting, and came across a question. Is the 1,432,500 sf of floor area including all proposed indoor square footage, separate from 1,191,339 sf of parking? So the total proposed project square footage would be 1,432,500 sf floor area + 1,191,339 sf parking + 31,507 sf landscape = approximately 2.7 million sf?
