In accordance with the California Environmental Quality Act (CEQA), the City of Los Angeles (City), as Lead Agency, has prepared an Environmental Impact Report (EIR) for the proposed Crossroads Hollywood (Project) to assess potential environmental impacts. An EIR is comprised of two parts, the Draft EIR and the Final EIR. Consistent with the requirements of Sections 15087 and 15105 of the CEQA Guidelines, the Draft EIR was submitted to the State Clearinghouse, Office of Planning and Research and was circulated for public review commencing on May 11, 2017. While CEQA requires a 45-day public comment period, the comment period for the Project was extended approximately one month to July 26, 2017, for a total review period of 76 days.

The Final EIR was released on May 4, 2018, and includes responses to comments received during the public review period and text revisions to the Draft EIR in response to input received. Unlike the Draft EIR, comments on the Final EIR are not required to be responded to by the City. If written comments are received, they will be included in the case file for the record and will be provided to the decision-maker for consideration. The EIR will be submitted to the decision-maker for requested certification and action on the Project.

PROJECT DESCRIPTION: The Project would retain and rehabilitate Crossroads of the World and the former Hollywood Reporter Building, remove all other existing uses on the Project Site, and construct a mixed-use development that would include eight mixed-use buildings with residential, hotel, commercial/retail, entertainment and restaurant uses, and a stand-alone, one-story commercial/retail building on the eastern edge of the Crossroads of the World complex. Upon buildout, the Project (including retention of the Crossroads of the World complex and the former Hollywood Reporter Building) would include approximately 1,381,000 square feet of floor area, consisting of 950 residential units (11 percent, or 105 units, for Very Low Income Households), 308 hotel rooms, and approximately 190,000 square feet of commercial uses. The proposed floor area ratio (FAR) would be approximately 3.81:1 averaged across the Project Site. In response to public comments and the recent nomination of on-site structures for designation on the local register, modifications to the Project subsequent to release of the Draft EIR have been incorporated, including preservation of the former Hollywood Reporter Building, retention of the alignment of Las Palmas Avenue, increasing the number of affordable housing units to 105 units, the addition of a parking structure within Development Parcel E, and an overall reduction in total floor area of 51,500 square feet.
