RE: Extension of deadline for comments on the Hollywood Center EIR

Dear Mayor Garcetti and Councilmember O'Farrell,

On behalf of the Board of Directors of the Broadway Hollywood building, I am writing to oppose, in the strongest possible terms, your decision to deny an extension of the deadline for comments on the EIR for the Hollywood Center project.

We are in the middle of a pandemic.

It is unreasonable and unfair for you to expect our community to organize a response while it is reeling from the hardship resulting from the City's own safer-at-home order.

This project will have a significant adverse impact on our community, and we ask for fairness in allowing us to have our voices heard.

We ask you to extend the deadline for comments on the EIR to 90 days after the Safer at Home project expires. Section 15105 of the Public Resources Code specifically provides the public review period can be extended under "unusual circumstances," and it is difficult to think of anything more unusual than the disruptions now occurring on account of the pandemic.
