The above projects are next to each other in Hollywood. Both project's Draft Environmental Impact Reports were issued several weeks ago. Our requests for additional time to review both of these massive project's DEIR's were denied by the Planning Department. It appears that both projects are being fast-tracked to start construction as soon as possible which would mean that both projects will be under construction at the same time. If this occurs, the impact on Hollywood, the surrounding communities and LA in general could be significant and severe.
