6 DANIEL WRIGHT: Thank you. Daniel Wright of the 7 Silverstein Law Firm. Commissioners, because you 8 removed from your agenda the Hollywood Center Project 9 items as to the entitlements, we have some general 10 comments on those entitlements, which may come before 11 you in the future.

You may recall that in 2013, our firm was involved in warning the City that Millennium and its attorneys were concealing the presence of a strand of the Hollywood surface rupture fault, which could shred the foundation of the proposed luxury towers.

When Eric Garcetti and Mitch O'Farrell ignored our warnings and approved Millennium's luxury towers on a rupture fault, it earned this city international ridicule.

It is encouraging to see that the item has been removed from your agenda and that Councilmember O'Farrell has finally called for what appears to be some kind of seismic investigation, although his letter is indistinct.

Page 4 We call for that the seismic needs to be overseen 1 2 by an independent geology team as requested by Councilmember Roux (phonetic). Moreover, it must be a 3 4 fully open, transparent process done with protocols known and approved by independent experts in advance, 5 б including to trench deep enough and far enough south as demanded by the California Geologic Survey in their 7 July 16th, 2020, letter, and it should be on both 8 9 sites, east and west.

Further, the U.S. Geologic Survey should also be invited onto both sites to conduct additional guided wave studies. And all of this must occur now before any further processing of the project and before any certification of the EIR. In fact, the current certification of the EIR by the advisory agency appears to be premature, given these --
