To Whom it May Concern:

This letter is in response to the release of the Hollywood Center Project Draft Environmental Impact Report (EIR) that was made on April 16, 2020.

We respectfully ask that the comment period be extended to 90 days in light of the emergency shelter in place orders that are in effect until May 15. We understand the comment period for a Draft EIR is normally 45 days. However, we are in living in unprecedented times, and Neighborhood Councils are severely hampered from effectively gathering public input during the current pandemic.

A project of this scale will impact the extended community beyond Council Districts 13 and 4. Greater Los Angeles will be affected due to the development's proximity to crucial city transportation routes and the Hollywood Earthquake Fault Line. In addition, there are a myriad of other impacts that deserve a clear and transparent process which allows the community to weigh in on this matter. We hope you can accommodate the community during this limited times of public interaction.
