The Hollywood United Neighborhood Council's (HUNC) Board of Directors at their August 10, 2020 Board Meeting voted to send this request:

Notice has been issued for the Planning Department's hearing set for August 26, 2020. The final EIR has not been issued as of this date. It appears that the department plans on hearing this project regardless of the issuance of the EIR. The Hollywood United Neighborhood Council requests a 60 day extension from the date of the issuance of the final EIR to review it and submit comment as setting a hearing for a project as large as this one without the final EIR or with only one week to review the EIR is unprecedented.

This is in addition to the 1756, 1760 North Argyle Avenue project (Case No. VTT-73748) hearing being scheduled 7 days before on August 19, 2020, again, without the final EIR being issued or if issued beforehand with only a little more than one week to review. These are two major projects literally next to each other that have been proposed for several years. To schedule hearings this quickly after the draft EIR comments were submitted and to allow virtually no time to review a final EIR is a substantial issue and one that affects not only Hollywood but much of Los Angeles due to the combined size and affects they will have on the Hollywood Freeway and the severe increase of anticipated traffic from these projects. Also, to schedule these projects this quickly and close

together without time to review is puzzling given that the project has been under review for several years.

A concern of HUNC is that with the current land use corruption allegations being pursued with the Los Angeles City Council that to schedule hearings this quickly with little to no chance for significant public input would seem to be counter-productive to the city's need to demonstrate that the land use review process is open, fair and complete.

As a result of the above comments, we urge the Planning Department to postpone the hearing scheduled for this project for 60 days following the issuance of the final EIR.
