

An ordinance amending Section 12.04 of the Los Angeles Municipal Code by amending the zoning map.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS

Section 1. Establishment of the Reseda Central Business District Community (CBD) Design Overlay District. The provisions of this Ordinance shall apply to any lot located in whole or in part within the shaded area on the following map, identified as Reseda CBD Community Design Overlay District (CDO) Boundary map.

Section 2. Zoning Regulations. Section 12.04 of the Los Angeles Municipal Code is hereby amended by changing the zone classifications upon a portion of the Zoning Map incorporated therein and made a part of Article 2. Chapter 1 of the LAMC, so that such portion of the Zoning Map shall conform the zoning on the map set forth in section 1 of this Ordinance. All lots located within the Reseda Central Business District Community Design Overlay District shall carry the suffix CDO as part of their zone classification. The suffix CDO refers to the Community Design Overlay District Design Guidelines and Standards adopted by the City Planning Commission pursuant to Section 13.08 of the LAMC.

Section 3. The City Clerk shall certify to the passage of this ordinance and have it published by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the City Hall; one copy on the bulletin board located on the ground level at the Los Angeles Street entrance to the Los Angeles Police Department; and one copy on the bulletin board located at the Temple Street entrance to the Hall of Records in said City.
