THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:


Section 1. Pursuant to Section 12.20.3 of the Los Angeles Municipal Code, the Sunset Square Historic Preservation Overlay Zone is hereby established for the properties located within the shaded borders of the zoning map depicted below.

Section 2. The Zoning Map referenced in Section 12.04 of the Los Angeles Municipal Code is hereby amended by changing the zone for the properties located within the shaded borders of the zoning map depicted below to R1-1-HPOZ and R3-1XL-HPOZ.
