**PROPOSED PROJECT:** An ordinance amending Section 12.22 of the Los Angeles Municipal Code (LAMC) to permit and regulate the use of an owner-occupied unit subject to Chapter 15 of the LAMC ("Rent Stabilization Ordinance") for home-sharing as an accessory use.

**PURPOSE:** The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The hearing will be conducted by a Hearing Officer who will consider all the testimony presented at that time and any written communication received prior to or at the hearing from affected and/or interested persons regarding this proposed code amendment, as well as the merits of the draft ordinance as it relates to existing land use regulations. After the hearing, City Planning staff will finalize a report including a recommendation that will be considered by the City Planning Commission at a later date.

Please call the staff contact indicated at the top of this notice several days in advance to assure its availability. Case files will not be available for inspection on the day of the hearing.
